1. Roberta Farrar – College of the Redwoods – LVN Program (2 locations)

- Weekly testing students scramble to get results staff to do tracing and paperwork.
- One student tested positive
- Clinical site paying for COVID Testing.
- RN psych had to get tested every two weeks.
- Providing full PPE (provided by college) hospital will provide face shield.
- Use a teaching assistant (part time RN) to supplement faculty.
- Have LVN/Paramedic to RN track using all on line now. Happy to chat with Christy Myers. <u>Roberta-farra@redwoods.edu</u>
- Skills lab-students screened daily and must wear face shield/mask/gloves if touching another person in lab.

2. Christi Myers - Lassen College - Director of Nursing

- Students meeting in person now and already use Canvas pre-COVID.
- Very few cases of COVID in the area.

4. Roxanne Haynes – CTE (Dean) Lassen College

• **Christi Myers** is her DON of LVN (plus other allied health programs) wants to grow all programs.

5. Carol Scobie - College of the Desert - Director of Nursing

- Currently LVN program on hold did not accept a new cohort this fall
- Faculty ratio in spring will be 1 to 5 due to faculty oversight with COVID
- Students are cleaning desk between classes Need training? Check CDC website.
- Skills labs One door in and another out for students?

6. Rosette Strandberg – Santa Barbara City College - Director of LVN

- Able to start LVN program this fall
- Have a CNA program but due to COVID unable to start this fall.
- Had some students test positive but not making them be tested again and they
 may return if MDs OK.

- Using both acute care (Lompoc, Urgent Care Centers/Cottage HC/ 4 long term care) – however each facility has different requirements for COVID rules/PPE/Testing
- Weekly testing at some LTC facilities. Every organization has different rules for nursing students.
- Had to reduce the total number of students at each facility 6 students only!
- So having to manage smaller cohorts which means more clinical sites.
- Rotating clinical faculty to cover all cohorts. Increase in faculty cost!!
- Requiring more overall program management to make things work
- What are the faculty to student ratio for clinical? 10 to 1/6 to 1/12 to 1/15 to 1 (with teaching assistant- part time LVN or RN with at least 2 years of experience).
- Students in skills labs have same cohorts and same partner for lab.

7. Sue Simpson - Mira Costa College (Oceanside) - Department Chair & LVN Director

- Able to start a new cohort in August
- Just now moving into clinical LTC one student tested positive (now hospitalized).
- Have alternative assignments/simulations for sick students
- Weekly testing for students and faculty in LTC
- Kaiser closed to students at this time

8. Laurie Meyers – Butte College – Nursing Director (RN & LVN)

- Able to find clinical placements for students so far

13. Sherrie Loewen – Dean of Health Sciences at Chaffey College

- Testing students weekly free from Co. Health Dept.
- This week 6 positive! So students out of clinical for 2 weeks (Including Sim Tech)
- Quarantine for 2weeks. Must test negative before going back into clinical
- Alternative assignments for students if sick or if cohort quarantined
- Risk adverse stricter rules than current CDC guidelines Want to be conservative
- Using their own college policy for how to address COVID, but if a facility has some other protocol in writing with them may allow student to return if asymptomatic.
- Have not had a student test positive twice as yet
- Kaiser Is open for student in acute care (Rad tech and AND)

14. Gina Weeks - Riverside City School of Nursing – Department Chair

- College providing PPE for students (including face shields)
- Only in acute care right now Not back in LTC as yet.
- Kaiser not back in clinical till spring.
- Already using simulation and have EMR program "DocUCare".
- Also Kaplan Simulations as part of the student's options.
- College has Sim lab certification using above products at Sim Directors suggestion

 made their own videos with faculty.

- "Course Point Plus" student cost (bundled about \$300.00) another option
- LVN cost of simulation but use thought program.
- Looking at starting Paramedic to RN

15. Eileen Donnelly – Allen Hancock College - LVN Director

- 3 semester program Used simulation to finish students had hours to make up from last semester.
- Using weekends and now back on track with cohorts up to date.
- Long Term Care not open to students in her area yet. May start acute care rotation earlier than planned.
- Large area for clinical SLO and Lompoc facilities

16. Enna Trevathan - Gavilan College - New Dean (came from San Mateo)

- Long term care not allowing students for CNAs
- LVN no LTC local 2 hospitals with rehab splitting cohorts for clinical
- Hard to find faculty for CNA classes CDPH & HWI worked together to ease requirements for faculty a few years ago.
- Doing some online simulations
- Will do full contact tracking if student is positive
- Emergency team putting out recommendations for staff & students re: COVID precautions.
- Students and faculty are cleaning skills lab after each group then deep cleaning every night.
- Skills lab only one door but have a station by door for student screening and reminders (removal of gloves and antibacterial gel for hands etc.)
- Sent acceptance letter for next cohort of students informed the students of COVID risk.

17. Gwen Ross - Clovis Adult School -

- Two different shifts per day of students for skills lab (AM/PM) with COVID cleaning in between each group surface cleaning only till nights.
- Clinical wearing N95 and face shields.
- Student/Teacher ratio 10 to 1
- Never had to stop her programs kept going using Zoom.
- Starting a new program in January (?)
