Pharm Tech Pathways: Retail or hospital or both

State licensure required: 240 hours of any training on the job or apprenticeship or accredited or non-accredited program. 3 changes to pass exam. \$129 plus background, fingerprints, HS grad, drug test and \$195 OR have National Certification.

National Certification: See link above. Retail not requiring, hospitals requiring. Hospitals pay more. If they get this first, they can get a license. Schools that are accredited can register and get information on graduates.

There are some Pharmacy Clerk and Pharmacy Aid programs at high schools, more information needed

LMI shows that there is a need, but the wages report low. #1: Wendy to ask for updated LMI from COE. #2: Wendy to send template to members to get accurate data from employers on wages

CSULB and CSULA have Pharm Tech programs in which credit counts towards their pharmacy degree.

Labs: For ASHP accreditation, must have a lab with certain equipment, see ASHP website for more information on equipment and process.
